THE PURPOSE OF THE FUND WAS TO SEGREGATE \$16,000 OF UNRESTRICTED NET ASSETS FOR INVESTMENT AND GROWTH TO SUPPORT THE OPERATIONS OF THE FOUNDATION. THE FOUNDATION RECEIVED INTENTIONS TO GIVE TO THE OPERATIONS ENDOWMENT TOTALING APPROXIMATELY \$687,949. THE BOARD HAS IMPLEMENTED A CAPITAL DEVELOPMENT PLAN TO FURTHER GROW THE OPERATIONS' ENDOWMENTS. IN FEBRUARY 2016, THE FOUNDATION ENTERED INTO AN AGREEMENT WITH CAPITAL DEVELOPMENT SERVICES ("CDS") WHEREBY CDS AGREED TO PROVIDE STRATEGIC FUNDRAISING CAMPAIGN COUNSEL FOR THE FOUNDATION. IN CONJUNCTION WITH THE CAPITAL DEVELOPMENT PROJECT, THE BOARD APPROVED UTILIZING UP TO \$90,000 OF ENDOWMENT FUNDS TO COVER THE COSTS OF THE CDS CONTRACT ALONG

WITH THE OTHER COSTS INCURRED BY THE FOUNDATION TO INCREASE FUNDRAISING EFFORTS RELATED TO THE OPERATIONS ENDOWMENT REACHING ITS \$2,000,000 GOAL. THE BOARD'S INTENTION IS FOR THE FOUNDATION TO REPAY THIS AMOUNT TO THE ENDOWMENT OVER TIME. AT YEAR-END THE QUASI-ENDOWMENT FUNDS WERE HELD IN MUTUAL FUNDS AND ETFS.
